CFESA Members who provide service and OEM parts to the end user, serve as “ambassadors” for the manufacturers of commercial cooking and refrigeration equipment. CFESA trained technicians become the final link manufacturers have with their end users. Recognizing the need to continue close communications with foodservice equipment manufacturers, CFESA established the Associate Member category. Associate Members, as defined in CFESA Bylaws, Article II – Membership (c), “Any firm, partnership or corporation actively engaged in the business of manufacturing commercial foodservice equipment shall be eligible for membership as an Associate Member of this association.”

OEM Parts

OEM Parts are essential for superior, safe performance, securing warranty compliance and maximizing performance throughout the equipment’s life cycle. When comparing OEM to generic parts key considerations are:

- Food & Employee Safety
- Equipment Lifecycle
- Warranty
- Agency Approvals
- Energy Efficiency

Reviewing the strengths and benefits of both OEM parts and generic parts, any initial cost savings achieved by using generic parts may end up costing much more in the long run due to warranty suspension, inability to meet third-party safety standards, employee safety issues and, ultimately, a shortened life cycle. If a generic part functions at 95% of the original part’s efficiency and has a lifespan rated 80% of the OEM part while costing 20% less, end users risk losing thousands of dollars due to unit downtime while spending more in utilities to operate.
